The statutory auditors have issued review report with unmodified opinion on these results.
- The Board of Directors at its meeting held on 23 October 2019 has considered, approved and recommended a bonus issue of shares of one equity share for every one equity share held by the equity shareholders of the Company. The bonus issue of equity share is subject to the approval of the shareholders and any other applicable statutory and regulatory provisions.
- Financial results for all the periods presented have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time, prescribed under Section 133 of the Companies Act, 2013 and other recognized accounting practices and policies to the extent applicable.
- On 7 December 2018, the Group had signed a definitive agreement to acquire business relating to select CRM software products for ₹ 12,352 crores (USD 1,775 million). Acquisition has been consummated effective 20 June 2019. Accordingly the financial results for three and six months period ended 30 September 2019 includes results of the above acquired business.
- Effective 1 April 2019, the Group has adopted Ind AS 116, Leases, using modified retrospective method. The Group has elected the practical expedients, which allow the Group not to reassess, its prior conclusions about lease identification, lease classification and initial direct costs. The comparative information is not restated in the financial results. In the statement of financial results for the current quarter and year to date period, the nature of expenses in respect of operating leases has changed from lease rent to provision payable to depreciation cost for the right-of-use assets and finance cost for interest accrued on lease liability.
